## **President's Message**

It's approaching the end of March. The first 3 months of the year were very productive around our community. We recently closed escrow, (March 12) on the purchase of the Maintenance Yard/Fire Station. The Office, Library and inside Restrooms has had a makeover and looks great. The pool and pool area has been worked on and will be ready for this upcoming season.

There is an Ad Hoc planning committee headed by Rod Olguin that is meeting to brainstorm on things that we can offer or have at the West Ramp, Maintenance Yard, Entrance /Gate area and Campground. If you would like to be in this committee, let the office know.

We are currently around 45% (755 feet of elevation) capacity for the lake level. The recent release schedule by MCWRA calls for major leases of the water beginning by April and dropping the levels to 20% by Memorial Day and minimum pool near the end of July. Note: our ramps are out of water near 24% 730 feet of elevation. See the Petitions in this edition developed by NRWMAC to protect our lake. Urgent action is required. We need 5000 signatures on each.

Mussel inspections are a must. Request Code Enforcement to come to your house to ensure your inspection is current.

### **Upcoming projects:**

WE have received the permit from the County for our proposed wheelchair lift. We are currently receiving bids for the cement work need for the elevation and drainage for the area where the lift will be placed.

Main entrance road overlay is still on for Fall. We are waiting on the CSA 7 sewer repairs and expansions that may affect the roadway before way finalize the date to start this project.

Thank you to each and every person, volunteer, owner and renter that help make this community the community it is. There's no better place. We are so lucky.

We all are hoping for more rain in the upcoming weeks to help the lake level!!

**NACIMIENTO REGIONAL WATER MANAGEMENT ADVISORY COMMITTEE****Oak Shores Urgent Action Required**

If the Monterey County Water Resources Agency (MCWRA), which controls all the water in Lake Nacimiento, had a motto, it would be: "If you don't like what we did before, wait until you see what we do next."

This lake is currently at about 44 percent of capacity; almost a year ago it was over 96 percent. Why the big difference? It's partly because of the drought. However, it's largely because MCWRA has been busily dumping 60 cubic feet of water per second (60 cfs) from the lake into the Salinas River. That amounts to over **37 million gallons per day**.

And guess what they're planning next? MCWRA is going to ramp up the release of water to 295 cfs during the month of March, and up to 400 cfs from April through the middle of July. At this rate, we'll be lucky to have enough water left in the lake by Memorial Day to launch a kayak.

Mark Twain is thought to have said, "Whiskey is for drinking, water is for fighting over." If you'd like to join our fight to stop this massive, unprecedented taking of water, please read and sign the petition (Pages 6) that the Nacimiento Regional Management Water Advisory Committee (NRWMAC) has published on our website. Copies are also available in the Oak Shores Office.

Monterey County has also all but eliminated law enforcement on Lake Nacimiento by reducing the staffing level of Park Rangers to one, who shows up at this lake only very occasionally. NRWMAC has tried, unsuccessfully, to get Monterey County to rethink this move, but they have not.

Meanwhile, although the San Luis Obispo County Sheriff's Office attempts to fill the void, it does not have sufficient staffing to dedicate to the task, nor the same training, nor, frankly, the same responsibility. So, NRWMAC is circulating another petition on Page 7.

We have the goal of obtaining at least 5,000 signatures on both petitions. The voices of that many citizens will be hard to ignore. We will then submit the petition to the Monterey County Board of Supervisors, the San Luis Obispo County Board of Supervisors and the California State Department of Water Resources.

The petition itself explains this critical situation, and includes the online link for signing it. There are also copies of the petition in the Oak Shores office. Many Thanks.

**SAVE THE DRAGON  
PETITION TO PROHIBIT THE PROPOSED  
WATER RELEASES AT LAKE NACIMIENTO\***

**We, the undersigned, are concerned citizens and residents who demand that the Monterey County Water Resources Agency (MCWRA), be prohibited from proceeding with its stated plans to increase the rate at which it releases water from Lake Nacimiento.**

MCWRA has recently published its Draft Water Release Schedule for the balance of the year 2018 for Lake Nacimiento and Lake San Antonio. Beginning in mid-March, 2018, MCWRA will increase the rate at which it releases water from Lake Nacimiento from the current 60 cubic feet per second (cfs) (38,776,320 gallons per day) to 295 cfs (190,650,240 gallons per day). In mid-April, the rate of release will have increased to 400 cfs (258,508,800 gallons per day.) This amount of water will continue to be released until approximately the middle of July, 2018, at which time the rate will be reduced to 180 cfs (116,328,960 gallons per day).

This wholesale taking of water is unprecedented and unacceptable. The elevation of Lake Nacimiento, as of March 2, 2018, was 752.8 mean feet above sea level (msl). This already equates to a lake capacity of only 43 percent. If MCWRA is allowed to release water in the amounts it has indicated it will, and assuming the lake does not get any "significant" rainfall in the next couple of months, the expected affect on lake levels, and consequently on lake activities and water consumption, will be devastating. For example, by Memorial Day, 2018, the lake will be at approximately 725 msl, or 20 percent capacity. There will be no gas available at the Marina, the resort will be forced to layoff personnel, and many docks and most launch ramps around the lake will be unusable.

In addition to recreation, some of the approximately 5000 residents of communities and private homes that surround Lake Nacimiento, as well as businesses, draw water directly from the lake for their own consumption. At critically low lake levels, many of these individuals will be unable to draw water from the lake and will have to rely on ground water wells. Those who will be forced to rely on ground water wells will experience greater costs to extract and treat this water, and will experience reduced water quality.

MCWRA has a long and disgraceful history of mismanaging water resources. The agency wasted over 190,000 acre-feet of water in 2017 by allowing it to spill into the ocean. It explained this massive release by claiming it was necessary to accommodate a large storm. However, not long ago, the same agency installed the Obermayer bladders at the Lake Nacimiento spillway, at a tremendous expense, vowing that it would allow them to eliminate the Flood Rule Curve by giving them more control during flood conditions. (With the Obermayer bladders down, MCWRA can, if necessary, release over 105,000 cfs or 67,858,560,000 gallons per day.) Yet even with the Obermeyer bladders in place, the agency still wasted all that water.

While we recognize the Salinas Valley farmers need water, and they are entitled to their fair share, we abhor the way MCWRA has mismanaged this precious resource. MCWRA is obligated to manage the water it controls for the benefit of all of the citizens of California. MCWRA's license from the State Water Board enumerates the various uses for the water, which are "... for irrigation, domestic, municipal, industrial, and recreational uses." The "recreation" component is just as prominent as any of the other stated uses. There is not an allotted percentage among them – they all have equal weight. Yet it is always, and only, the recreational use of this lake that is adversely affected by the release of water.

Please consider signing this petition. It will be presented to the California State Water Board, Monterey County Board of Supervisors, the Monterey County Water Resources Agency, and the San Luis Obispo County Board of Supervisors.

PETITION TO RETURN PARK RANGER STAFFING  
TO SAFE LEVELS AT LAKE NACIMIENTO**

***We, the undersigned, are concerned citizens and residents who demand that a minimum of seven full time Monterey County Park Rangers be redeployed exclusively to Lake Nacimiento and surrounding areas. We believe that seven Park Rangers constitute the minimum staffing level necessary to enforce the law, to provide safety for locals, visitors, camping and boating, and to protect the lake waters from invasive mussels.***

***Over the previous two years, the Monterey County Parks Department has reduced the number of Park Rangers and other Parks Department employees on Lake Nacimiento to a dangerously low level. In the past, there were as many as 30 Park Rangers patrolling Monterey County parks, including Lake Nacimiento. Now there is only one Park Ranger on patrol at all of these parks, and comes to Lake Nacimiento on only a part-time basis.***

***This must change. Park Rangers are responsible for law enforcement and perform many vital functions, including, but not limited to, the following:***

- Citing and arresting intoxicated boaters;***
- Citing reckless boaters;***
- Citing boaters who do not possess daily or annual passes;***
- Performing invasive mussel permit inspections and citing violators;***
- Providing emergency services in case of a catastrophe, such as fires, drowning and boating accidents;***
- Maintaining channel buoys to keep boaters from running aground; and***
- Being a deterrent to dangerous behavior by their visible presence.***

***It takes a minimum of three Park Rangers in order to put one Park Ranger Boat on the lake (two Park Rangers in the boat and one at the Resort Marina). With shift coverage and days off it takes at least seven Park Rangers in order to keep a boat on the lake. Campers pay Monterey County as much as \$47.00 per night to stay at the resort; boaters pay \$100.00 per vessel for a yearly lake permit; day use is \$10.00; and dock owners pay \$60.00 for each dock. Monterey County continues to collect this money yet fails to provide the safety and security we rely on for our fees.***

***Unfortunately, there have been a number of deaths on the lake caused by reckless and/or intoxicated boaters, resulting in accidents and drowning. Thefts and gang activity are on the rise. Boaters are using the lake without fear of having to provide proof of either a mandatory mussel inspection or an annual or daily pass. On a busy weekend there can be hundreds of campers and thousands of boats on the water. When there are no Park Rangers it becomes a virtual free-for-all. And word is getting out. For some, it might seem welcome news that law enforcement has been so severely depleted, but for the great majority of us who use the lake, it is entirely unsatisfactory. We want and need to know that in the event of an emergency or catastrophe that there are trained people available to help. We expect to have our lake waters protected from the devastating effect of an irreversible infestation of invasive mussels. We demand full time Park Rangers be returned to Lake Nacimiento at the staffing levels necessary to provide for our safety and to enforce the law.***



## Community Plan Ad Hoc Committee Formed

Formed in March, the Ad Hoc Committee, consisting of community members and staff, has been meeting to formulate a Community Improvement Plan. Intended as a way to initiate a discussion on how the community would like to shape the future of its amenities, the Plan can serve as a blueprint for future improvements. ## **FIRE WISE Committee Update – MARCH REPORT**

Fire Wise wishes to thank each of the “Poker Run” (October 21) participants. We had sixteen vehicles and approximately 50 people. Special thanks to Gerry and Connie Main for sponsoring a “refreshment stop” at the midpoint. Another special thanks to Mark and Peggy McMullen for the idea and organizational skills. The event took in over \$900. Each of the three winners donated their prize money towards the defibrillator. We also had six separate donations! We raised enough to purchase a \$1700 defibrillator! At this printing the device has been ordered, will be donated to OSCA, and placed in the on-duty patrol vehicle. Each of the patrol officers is trained on the device. Thanks to all who helped with this community effort.

I felt it necessary to review two items: (1) events sponsored by Fire Wise, (2) financial support to OSCA. Events: (1) Memorial Day BBQ and band, (2) July fourth Art Sale Fire Wise/Rec. committee, (3) Red Cross First Aid/CPR training for employees (paid by OSCA) and residents (Fire Wise paid half of fee), (4) “Poker Run”. We hope to again sponsor these events in 2018! Financial support to OSCA: dead tree removal, and chipping to supplement grants-\$7,000, (2) yellow plastic letters for entry board “Fire Wise says! \$150, (3) First Aid/CPR class for members half paid by Fire Wise \$700, (4) “Poker Run” including donation for defibrillator \$1700.

Fire Wise will be co-sponsoring with Recreation the Fireman’s Ball this spring. We will have two fund-raisers: (1) Memorial Day BBQ with \$8.00 dinners (hamburgers/hot dogs with fixings). We will have a band or DJ and there will be Fire Wise literature for home/grounds safety. (2) Poker Run on October 20<sup>th</sup>. This event was very popular and we may also have one during the summer. Our fund-raiser will help the association with dead tree removal and brush clipping after grant money is exhausted.

Financially, we have \$7800 in our budget. We have already committed \$800 for first aid kits for our maintenance/patrol trucks and money to replace five Stihl commercial weed whackers. We are hoping for grant help from Stihl. This again means no cost to OSCA and no money taken from the general fund. Please support our fundraisers so we can continue to help OSCA.

Time to replace batteries in your smoke detectors and carbon monoxide devices. Be safe with firewood storage, none under decks, as that can become fuel. Have a safe spring.
